



# CORPORATE / EVENT CHAIR MASSAGE CONTRACT

- This contract is made by and between \_\_\_\_\_ located at \_\_\_\_\_ ("Company"), the contact for which is \_\_\_\_\_ and **Tranquility Base Massage Therapy®**, ("Contractor") the contact for which is Jason DeVries, Owner.
- Contractor will provide chair massage sessions at 15 minute intervals with three clients per hour, allowing for adequate clean-up/set-up time between each client. The contractor will provide all equipment necessary to perform chair massage: massage chair, sanitizer, lotion/oil (if necessary), aromatherapy supplies, release/waiver forms, and music (if permitted by company).
- Company will provide a quiet space for the chair massage, not smaller than 6'x6', with functioning lights, an electrical outlet and trash bin. Furthermore, the Company will provide and schedule the clients, three per hour at 20 minute intervals (15 minute massage + 5 minute clean-up).
- Contractor will be available up to an 8-hour session, with one 1-hour unpaid lunch break. Every 2 hours the therapist will take an unpaid 10-minute break.
- Contractor will charge as a fee for service \$45 per hour, equaling \$1 per minute in session, with a minimum of \$135. Company pays all of the amount for their session, using cash, corporate check or any major credit card at the time service is rendered.
- Title 25, Texas Administrative Code, Chapter 141, requires that all Clients read and sign a form prior to their first massage session. Contractor will provide the release/waiver form that the Clients are required to sign prior to their session. Client is to have form filled out before entering their session.
- Appointment Cancellation Policy: Appointments must be canceled no later than 24 hours before the scheduled time. Failure to cancel within this time will require payment in full for scheduled services. Failure to cancel within the appropriate time will result in forfeiture of any special, certificate or gift certificate.
- Contractor may have inadvertent access to information about Clients and other employees, including proprietary information, trade secrets, and intellectual property to which the Company holds rights. Contractor agrees to keep all such information strictly confidential and to refrain from discussing this information with anyone else without proper authority.
- Contractor is a massage therapist licensed by the Texas Department of State Health Services. A copy of certificate of licensure will be furnished upon request.
- Contractor agrees to carry general liability insurance. A copy of certificate of liability insurance will be furnished upon request.
- This contract shall be made effective on and must be executed on the date of service, \_\_\_\_\_, and shall terminate by the end of day of service.
